

## INTRODUCTION

Each year, the City of Chicago is tasked with creating a balanced budget in order to decide how it will utilize its revenue to best benefit the city. The city budget funds programs and projects related to finance, legislation, planning and development, community services, public safety, regulations, and infrastructure. Though each of these areas represent essential services and resources required for our city to thrive, there exists an extreme disparity between the amount of funding allocated to the Chicago Police Department (CPD) and other city departments.

The budget consists of several funding sources; however, most of the sources have a predetermined use and rules on how the revenue may be spent. The corporate fund is considered the City's "general" fund, as it spends this money on City services such as public safety, public health, and infrastructure. This fund is sourced primarily through taxes and services paid to the city and is often the focus of the budget because it can be spent at the discretion of Mayor Lori Lightfoot and the City's 50 alderpeople.

In the proposed 2021 budget¹, the corporate fund is \$4,022,469,000. Of that amount, \$1,556,686,263 — 38.7% of the corporate fund — is allocated to the Chicago Police Department with the idea that it will keep the public safe. This amount does not include spending on police settlements or pensions. Despite calls for divestment from police and investment in community services, the City of Chicago is currently preparing to spend \$4,264,893 on the Chicago Police Department per day next year. To compare, community services have been allocated the following budgets for the whole year:


» Family & Support Services: \$95,388,336

» City Development: **\$21,902,754** 

» Violence Prevention: \$16,500,000

The proposed 2021 budget includes expanding initiatives that fail to address the root causes of violence which has been named as a top issue for residents and elected officials. Rather, they further our investment in policing, despite the fact that as police funding has increased in Chicago, so has crime and violence. We recognize that more policing does not and cannot keep our communities safe, and often has the exact opposite effect, as increased interactions between police and residents leads to greater criminalization of and violence against residents, particularly for Black, Brown, and Indigenous people.

services. In Mayor Lightfoot's citywide survey of over 38,000 residents, 87% responded that they want to defund the police to fund social services. Lightfoot is choosing to ignore Chicagoans by refusing to defund the police in her 2021 budget proposal while cutting valuable and necessary social services. Our alderpeople have the opportunity to VOTE NO on Lightfoot's budget and make amendments that would defund the police to fund services we need.

DefundCPD is a grassroots campaign demanding that the Chicago City Council defund the Chicago Police Department by 75%. We want the council to take resources and power away from the Chicago Police Department, which we recognize as a racist, violent institution that has too much power over our communities. Instead, we want our city to reinvest in community resources like quality, well-funded public schools, mental health centers, housing, and other social services and community institutions.

## What's in the Toolkit?

Our campaign believes another world is possible. We know that the Chicago Police Department fails to keep our communities safe and that—despite the harm they cause—multiple factors protect CPD's existence. We are choosing to reimagine the City's budget outside the constraints of the current system because we know the current system does not prioritize care for our communities and was built without the true democratic input of the people.

We hope you will use this toolkit to speak to City Council members, your friends, and neighbors about building towards a future without police.

## SECTION 2: HOW WE DEFUND THE POLICE

## INTRODUCTION

## WHAT ARE THE GOALS OF THIS SECTION

Section 2 starts with a breakdown of the City's 2021 Budget Proposal and the 2021 Budget Survey results. The next sections detail where we propose the 75% cuts in the CPD budget would be made and where that funding could be redistributed to community services and investing in people, not violence.

## **Budget Survey Results**

## The Budget Survey Results are Clear: Defund CPD

This fall, the City launched a public survey in order for residents to provide feedback to the Mayor's office for the 2021 budget. Over **38,000** people across every Chicago residential ZIP code responded to the survey. Respondents made it very clear that the priority of the budget should be Community Services (support for youth, homelessness, violence prevention) and Public Health (mental health, food protection) with 86% of respondents believing that they required additional resources. **Police Services ranked the lowest priority to residents**, with only 9% of respondents asking for additional resources to the police.

The survey respondents wanted to allocate 22% and 21% of the budget to Public Health and Community Services, respectively, while the 2020 Budget allocated for only 4% and 14%. The 2020 Budget allocation for Police Services was approximately 34% while the respondents asked to allocate only 6% to Police Services.

More than **90**% of responses said that the funds should be reallocated from current services rather than increase revenue sources. When asked which services to reallocate funding from, **87**% of those responses said to reallocate funding from the police budget. When respondents commented on ideas and concerns to the 2021 budget, **95**% of the comments received mentioned defunding CPD and reallocating police funding to communities to reduce crime.

"I am tired of wasting my taxpayer money for having incompetent police officers settling lawsuits with families who have to deal with harm from police." <sup>2</sup>


## WHERE RESPONDENTS WANT TO REALLOCATE RESOURCES FROM<sup>3</sup>



## THE ANSWER IS CLEAR

Chicagoans want our underserved communities funded and want the police defunded. Rather than increasing revenue through taxes paid directly by the city's working class, the people believe that funds should be reallocated from an ineffective policing system. We deserve a budget that our residents have demanded, a budget that serves our communities by reallocating our police funding into housing, mental health, youth, food protection, and community services, and we will not stop until we get it.


## **Budget Comparisons**

## 2020 CITY BUDGET BREAKDOWN<sup>5</sup>

The City of Chicago's services are broken down in the following 9 functional groups:

- » Regulatory Services
- » Cultural Affairs
- » Libraries
- » City Development
- » Streets and Services
- » Community Services
- » Public Health
- » Infrastructure Services
- » Public Safety
  - \*Police Services
  - \*Other Public Services (Fire, EMT)

## **Defunding the Chicago Police Departments by 75%**

## **Defunding the Chicago Police Department by 75%**

The current projected budget for the Chicago Police Department is set at \$1,556,686,263, which means that in order to cut **75% of the budget** we would need to cut approximately \$1,167,514,697. The following proposed cuts to defund the police by 75% will be laid out and explained in order from what is most feasible to least feasible.

## \$54,927,449 CUT PROPOSED BY CITY COUNCIL OFFICE OF FINANCIAL

**ANALYSIS (COFA)** DURING A JOINT VIRTUAL COMMITTEE ON BUDGET AND GOVERNMENT OPERATIONS / PUBLIC SAFETY.

- » \$30.5 million Cut tuition reimbursement programs and uniform allowances for police officers and commanders.
- » \$23.5 million Eliminate quarterly payments to sergeants and to those assigned to special units.
- » \$1 million Reduce police spending at O'Hare and Midway.

## \$91,360,002 CUT FROM POLICE OVERTIME BUDGET.

- » Cutting the police overtime budget has been a central piece in police budget cuts seen in other major cities such as New York<sup>7</sup> and Los Angeles.<sup>8</sup>
- » A 2017 audit of police overtime controls found that systems were not in place to prevent abuse of overtime and the 2020 follow up to this audit found that only 2 of 13 corrective actions had been fully implemented, showing the unwillingness of the police department to make changes and reform overtime abuse.<sup>9</sup> Even Mayor Lightfoot has expressed frustration regarding the large sums of money the city spends on police overtime.<sup>10</sup>

## \$76,191,580 CUT FROM NOT FILLING VACANCIES

- » Based on the average salary in the CPD,<sup>11</sup> this amount could be cut by leaving the current 847 vacancies open.
  - Mayor Lori Lightfoot proposed leaving 614 of these open in her 2021 budget address
- » Similarly to overtime cuts, this would follow trends by other major U.S. cities such as New York which canceled its' NYPD academy classes totalling in 1,100 cadets not being hired<sup>12</sup> and Milwaukee which proposed to cut 120 positions through choosing to not rehire.<sup>13</sup>

## Defunding the Chicago Police Departments by 75%

## \$82 MILLION CUT BY TAKING THE BURDEN OF SETTLEMENT CONDUCT OUT OF THE TAXPAYER DOLLARS

- » Over the past 10 years Chicago has paid over half a billion dollars in law suits, because cities often continue to fight against allegations where misconduct is clear, thus increasing attorney's fees and settlement amounts.9
- » A possible alternative could be liability insurance as recommended by COFA,<sup>10</sup> but the public should not be responsible for the misconduct of police officers.

## **\$863,035,666 FROM PERSONNEL CUTS**

- » Approximately 9,595 positions need to be cut from CPD.
- » Redirecting funds from CPD to violence interruption programs, health care, mental health services, housing, and youth programs will eliminate the need for such a large police department by funding other areas of the budget that actually keep us safe and are allowing for treatment not trauma.

While obstacles, such as FOP contract stipulations may prevent some of these stated changes from occurring legally, with political will and people power, we believe these necessary changes can occur. We choose to reimagine outside the constraints of the current system, since we know the current system was built without the true democratic input of all people.

Bottom Line: With political will and people power, we can overcome obstacles on the way to reimagining public safety outside the constraints of the current system.

### Where Will the 75% Go?

## Where Will the 75% Go?

At the heart of this campaign is a demand to defund the CPD by 75% and reinvest in people instead of violence and incarceration.. And so, where would that money go, and how could we build a police-free future? To address this question, we initiated a research project that used Lori Lightfoot's <a href="Mayor's Budget Recommendations for Year 2021">Mayor's Budget</a> to explore how funding could be reallocated to a broad variety of community services.

## **METHODS AND RESULTS:**

Community services were the highest ranked result of the 2021 Chicago Budget survey. 16 Therefore, we examined the budgets of various departments and programs that would serve Chicago better than police, including the Department of Public Health, the Commission on Human Relations, Office of Disabilities, Department of Family and Support Services, and the Chicago Public Library. Using the Mayor's 2021 Budget Proposal, we calculated how much we could increase the spending of their various programs.

Defunding the CPD by 75% would produce \$1,167,514,697. The following sections detail how that funding could be reallocated, see the Where Will The 75% Go Website<sup>17</sup> to learn more and create your own budget reallocation plan. You can adjust the spending amounts by typing in the value you would like to see in each category.

## **DEPT. OF PUBLIC HEALTH:**

The Chicago Department of Public Health (CDPH) is made up of several programs that promote the health and safety of the residents of Chicago. The 2021 budget recommendation for CDPH is \$57,174,490 (1.4% of the corporate fund). Even in a public health crisis, it appears that chronic disease services received ~1% or <1% of the proposed 2021 public health budget. Mental health services were recommended \$1,451,864 (.037%) in 2021, but this is not a sufficient budget to accommodate the number of people who need and lack access to

these services. We could increase funding to many of these programs by 150% to 200%, resulting in an additional \$100M funding, which would support trauma centers, access to medical facilities/clinics, programs that address environmental racism, and STEM (science, technology, engineering, and math) programs for underrepresented groups.

## **HUMAN RELATIONS:**

The Chicago Commission on Human Relations (CCHR) is intended to highlight the diversity of Chicago. CCHR also works to fight against bigotry, prejudice, and discriminatory practices. The 2021 budget recommendation for CCHR is \$1,065,905 (.026%). This entire department is made up of less than 20 full time employees (FTE). Expanding this department by 150% or \$10M is necessary to reap the benefits of such programs in a city of approximately 3 million residents.

## **OFFICE OF DISABILITIES:**

The Mayor's Office for People with Disabilities (MOPD) works to afford equal opportunities to people with disabilities in order to accommodate them in all facets of their lives. The 2021 budget recommendation for MOPD is only \$1,873,653 (.047%) with a significant portion of funds going towards administrative costs. More funds could go towards preventative programs and accessibility compliance costs, which currently receive less than \$1,000,000 per year, combined.

### Where Will the 75% Go?

## **DEPT. OF FAMILY AND SUPPORT SERVICES:**

The Department of Family and Support Services (DFSS) seeks to improve the livelihoods of Chicago families and children, namely those most vulnerable. The 2021 DFSS budget recommendation stands at \$95,388,336 (2.4%). While this budget is already sizable, increasing their funding by 150% would reach more families and children in need.

## **CHICAGO PUBLIC LIBRARY:**

The Chicago Public Library (CPL) promotes reading, literacy, and learning for all Chicagoans. CPL strives for the equal accessibility of knowledge and technology for residents and other visitors alike across 81 neighborhood locations. The CPL budget recommendation is \$72,911,461 (1.8%) for 2021. \$59,757,917 of this budget is allocated towards Harold Washington Library and Popular Library at Water Works while \$7,736,698 is split between the remaining libraries. More funds could go towards the remaining libraries, including those in underresourced communities. Libraries could improve community outreach and programs as well as hire more staff.

## **DEPARTMENT OF HOUSING:**

The current corporate fund allocation for the Chicago Department of Housing is \$9,993,237 (.25%) for 2021. In the greater Chicagoland area, there are 100,062 Affordable and Available rental homes for 323,342 extremely low-income renter households. Therefore, there is a deficit of 223,280 extremely low-income renter units. If Chicago wants to actually address its housing crisis, it needs to allocate the necessary resources to make a dent in the problem. \$5,000,000 of that nearly 10,000,000 went to the Chicago Low Income Housing Trust Fund. According to the 2020

Budget Overview, that \$5,000,000 was for the purpose of building 520 low income housing units. If that scales at say, 90% efficiency, \$250,000,000 would build 23,400 units. Continuously allocating that money over a 10 year period is one way to decrease the affordable housing crisis in Chicago.

## **CONCLUSION:**

These are just some of the ways in which we can build a police-free future. By investing in people and the things that they need, we keep us safe. However, the reallocations calculations listed above are not fixed terms, and true empowerment comes when the people can decide how they want to reallocate funds themselves. So check it out yourself and build your own police-free future!

Bottom Line: If we defunded the CPD by 75%, we could build more affordable housing, invest in community-serving institutions like libraries, and improve the livelihoods of the most vulnerable Chicago families and children.

## INTRODUCTION

## THE CASE FOR DEFUNDING THE POLICE AND UPLIFTING COMMUNITY SOLUTIONS

The call to defund the police is also a call to reimagine a city budget that actually invests in what communities need, like education, housing, and healthcare. Communities know what they need to thrive. Here are some ways Chicago communities are fighting for what they need despite city disinvestment.

## WHO IS THIS FOR?

## Food Security & Accessibility

## Food Security & Accessibility

Not all Chicagoans have equal access to supermarkets and healthy, affordable food. Many communities on the West and South Sides live in food deserts. For example, on 79th Street between Lake Shore Drive and Pulaski, there are zero supermarkets. The Food Empowerment Project defines food deserts as "geographic areas where residents' access to affordable, healthy food options (particularly fresh fruits and vegetables) is restricted or nonexistent due to the absence of grocery stores within convenient traveling distance." 19

Residents in Chicago's food deserts are organizing to meet their community's needs by creating community-led gardens and food distributions centers. Here are some examples:

- » El Paseo Community Garden in Pilsen proudly works to grow healthy food and strong community leaders through both private and collective gardening beds.
- » Onward Neighborhood House in Belmont Cragin partnered with the Greater Chicago

Food Depository to open a client-choice food pantry. A client-choice food pantry offers residents the opportunity to choose fruits, vegetables, dairy, frozen meats, bread, grains, and breakfast foods from various food stations as if they were in a supermarket.

- » Grow Greater Englewood's mission is to be "a social enterprise that works with residents and developers to create sustainable, food economies and green businesses to empower residents to create wellness and wealth."<sup>20</sup>
- » Belmont-Cragin Mutual Aid collaborates with other neighborhood mutual aid efforts and local nonprofits to help folks get the food, supplies, and masks and gloves they need during the COVID-19 crisis.

## Covid-19 Response & Healthcare

## **COVID-19 Response & Healthcare**

The COVID-19 pandemic and the corresponding economic crisis has increased the need for free, comprehensive healthcare. The Chicago Department of Public Health only represents 1.9% of Mayor Lightfoot's proposed \$11.65 billion city budget.<sup>21</sup> In 2012, the city closed half of its public mental health clinics.<sup>22</sup> When we defund the Chicago Police Department, we can invest in healthcare initiatives—both new and existing ones that have already been established by communities.

» Northside Action for Justice, an organization dedicated to advancing economic and social justice on the North Side and beyond, provided

- free flu shots and COVID-19 tests in Uptown in October. Access to COVID-19 tests for all members of our community, regardless of their insurance status, is essential to keeping our communities safe.
- » Mutual aid groups such as the <u>Uptown Buena</u> <u>Park Solidarity Network</u> packed kits with sanitizer, hand wipes and face masks for neighbors. Others distributed masks and other PPE to the community.
- » The <u>Chicago Coalition for the Homeless</u>
  Mutual Aid Fund provided one-time emergency grants of up to \$500 to individuals or families

- experiencing homelessness, including people staying at a shelter or living doubled-up with family or friends.<sup>23</sup> This assistance helps people secure temporary housing to quarantine safely and limit the spread of COVID-19.
- » Collaborative for Community Wellness, a coalition of mental health professionals, community-based organizations and community residents, conducted a research project to "collectively tackle the multiple barriers to mental health access." <sup>24</sup> They recommend expanding long-term, trauma-informed mental health services.
- » Broadway Youth Center (BYC) in Uptown provides healthcare and other services to transgender, queer, lesbian, bisexual and gay youth, especially young people who do not have stable housing.<sup>25</sup> BYC sees anyone, regardless of ability to pay.
- » Parent mentors at <u>Brighton Park Neighborhood</u> <u>Council</u> host community health fairs and do outreach to connect their neighbors to health resources across the city.<sup>26</sup>

- » <u>Chicago Abortion Fund</u> provides financial, logistical, and emotional support to people seeking abortion care.<sup>27</sup>
- » <u>Chicago Birthworks Collective</u>—a collective of birthworkers, healers, and wellness practitioners serving Black families—provides prenatal pregnancy, birth and postpartum services.<sup>28</sup>

## **Harm Reduction and Community Safety**

Police only respond to harm after it has occurred, if they respond at all, and that does little to actually reduce harm and heal from its impacts.<sup>29</sup> With the comparatively little resources they are given, communities have been forced to take on the tasks of addressing the root causes of harm and healing, while still facing the ongoing threat of violence from the punitive justice system. If we defund the police, we can invest in community initiatives that actually address harm with informed care, including the below examples.

» Uptown's <u>Alternatives</u> offers youth behavioral health services and restorative

- justice programs. The organization's stated purpose is "to facilitate personal development, strengthen family relationships, and enhance the community's wellbeing." <sup>30</sup>
- » Englewood nonprofit <u>Teamwork Englewood</u> recommends public safety strategies that include peace campaigns, restorative justice peace circles, after school programs and centers for youth to reduce arrests, and counseling programs (anger management and substance abuse) for 18-34 year olds.<sup>31</sup>
- » During June 2020, when the Latin Kings were committing anti-Black gang violence in response

to looting in the Little Village and North
Lawndale neighborhoods, CPD left residents
to fend for themselves. Community activists,
violence interrupters, clergy, local leadership,
and even gang-affiliated individuals spoke out
against racism on social media and mobilized
to de-escalate violent interactions. ChiResists
organized the first cross-neighborhood unity
march and then El Foro del Pueblo followed
with a Brown People for Black Power march in
Little Village. All of these efforts ultimately led to
Latinx and Black street gangs coming together
for understanding and moving towards unity.<sup>32</sup>

## Housing

Across Chicago, new housing developments have catered to wealthy residents and driven gentrification that prices low-income Chicagoans out of some neighborhoods.<sup>33</sup> At the same time, disinvestment in other areas leaves a glut of vacant homes that require refurbishment to become viable housing. All people have a right to housing.

Chicagoans across the city are already making grassroots efforts to build affordable homes for all, utilize vacant homes for folks experiencing homelessness, and end evictions and foreclosures. Investing in these efforts instead of the police department will go much further to improve the lives of Chicago residents.

» Belmont Cragin (30th Ward) has 2,188 vacant housing units,<sup>34</sup> but many of those units are not affordable (i.e., monthly payments exceed 30% of a household's monthly income). In 2019, there were only 261 affordable rental units for a neighborhood that is home to about 80,000 people<sup>35</sup>. Investment in rental assistance funds and eviction/foreclosure prevention programs, like Northwestside Housing Center, could help close this gap and keep folks in their homes.
Even before the crisis, a University of Illinois at

- Chicago study estimated that at least half of the homeowners in Belmont Cragin couldn't afford their mortgage.<sup>36</sup>
- » The Uptown/Rogers Park area (46th Ward) is one of top five Chicago neighborhoods in Chicago with the biggest affordability gap. 37 This means the number of renters in need far exceeds the number of affordable units. This gap disproportionately impacts the neighborhood's Black, Asian, and Hispanic residents. Between 2000 and 2016, the neighborhood's African American population declined by 20%, its Asian population dropped by 35%, and its Hispanic population fell by 45%38. Residents have responded by advocating for affordable housing and for a voice in development projects through groups like **Voice** of the People in Uptown, an organization which now co-owns four properties in Uptown that were recently acquired by **Preservation of** Affordable Housing. These will provide 192 apartments in 11 buildings for individuals and families.
- » On the South Side, <u>Southside Together</u>
  <u>Organizing for Power (STOP)</u> builds power

- among Woodlawn residents, touching issues like housing, mental health, and the police. Beyond advocating to reopen city mental health clinics and remove police from schools, STOP is also one of many organizations fighting for a community benefits agreement in the area around the Obama Center. They are fighting for the Washington Park, Woodlawn, South Shore, and surrounding area residents who face the risk of displacement. Half of Woodlawn's current population, almost 4,500 renting households, are at high risk of displacement.<sup>39</sup>
- » Teamwork Englewood's Englewood Quality of Life Plan II, developed in collaboration with residents and community stakeholders, highlights the need for investment in renovating vacant properties and an independent community advisory board to hold outside developers accountable to the best interests of the community. Their 2016 report stated that home ownership is declining, with only 27% of Englewood homes owner-occupied.<sup>40</sup> The plan further suggests vacant home renovation is an opportunity to "partner with veterans and"

## construction professionals to teach skills to youth and formerly incarcerated."41

## **Schools & Education**

Education is supposed to be a great equalizer, but how can that be when schools in Chicago's Black neighborhoods are overwhelmingly deprived of resources?<sup>42</sup> During the 2018-2019 school year, almost a third of Chicago Public Schools (CPS) had classrooms with no teacher for the whole year.<sup>43</sup> Schools serving low-income and Black students are twice as likely as other schools to have a yearlong teacher vacancy.<sup>44</sup> When we call to defund the police department, we are also calling for a reinvestment in public education. Here are some ideas from communities across the city:

- » Hire nurses, counselors, and family resource coordinators for every school. In 2017-
- 2018, CPS employed only 108 certified school nurses—that's one nurse per 2,859 students. The Chicago Teachers Union's latest strike won a commitment to place one nurse in every school over the next 5 years. However, CPS has said the district may face challenges finding quality candidates<sup>45</sup>. There's a need to invest money in training and finding quality candidates and a need to pay them proper salaries upon hiring.
- » Chicago nonprofit My Block My Hood My City serves underprivileged youth in different communities of Chicago and has been providing remote supplemental youth wellness and

remote activities during COVID-19.<sup>46</sup> Many after-school youth programs have come to a halt due to COVID-19. There's a need to expand after-school youth programs, so young students feel connected with their peers during these difficult, remote learning times.

- » The <u>Onward House</u> in Belmont-Cragin offers classes for Spanish-speaking, adult learners, including GED classes.<sup>47</sup> If more community-based organizations were able to offer more programs for adult learners and parents, like GED and computer classes, it would help provide more pathways to opportunity for more people in communities that have been left behind.
- » The <u>Englewood Quality of Life Plan II</u>, developed by Teamwork Englewood in collaboration with residents, proposes to help youth by "identifying existing reading

programs...to achieve at-grade level reading scores" and "attract capital and resources for student-led enrichment programs."48

## **Employment**

The COVID-19 pandemic has resulted in record-breaking unemployment rates, with Illinois seeing 1.9 million new unemployment claims since early March<sup>49</sup>. Mayor Lightfoot called police "one of the few tools that the city has to create middle-class incomes for black and brown folks."<sup>50</sup> Imagine if instead of spending \$4 million a day on the police, we invested those millions into actual job training programs and created pathways to high-paying jobs that did not require you to arrest and kill black and brown folks. Research from the University of Illinois at Chicago has shown that neighborhoods with the highest rates of violence are also those with high rates of joblessness.<sup>51</sup>

» In Austin, where about 25% of residents are unemployed, the <u>Jane Addams Resource</u> <u>Corporation (JARC)</u> recently opened a training center for jobs in the manufacturing center.<sup>52</sup>

- Opening the Chicago West Side Training Center is only one step in JARC's partnership with local non-profit Austin Coming Together to implement the Austin Quality-of-Life Plan and improve career opportunities in the community. The plan also includes the redevelopment of closed Emmet Elementary School into a workforce development and training center with resources like career development programs, vocational training, and apprenticeships for high-demand fields.<sup>53</sup>
- » Englewood non-profit Inner-City Muslim Action Network recently received a \$1 million grant from the city for their Green ReEntry Program. It provides 50 people with 12-month apprenticeships and 14 weeks of training in HVAC, electrical, carpentry and production welding, during which they will rebuild homes and apartments across the city.<sup>54</sup> Imagine how many

- more Chicago residents this program could serve if we took even a slice of the millions we spend on police.
- » This summer, the One Summer Chicago initiative offered 20,000 Chicago youth paid job and life skills training as well as online professional development groups. Research shows that youth joblessness leaves "permanent scars": it leads to decreased likelihood of employment later in life, decreased level of wages, decreased life satisfaction, and lowers self esteem.<sup>55</sup>

## **Environmental Justice and Building Green Spaces**

If we defund the police, we can build new green spaces and invest in those that already exist. We can build more community gardens and equip these spaces with free water and water equipment so residents can grow their own fresh produce. We can also rehabilitate parks, playgrounds, and paths to encourage a lifestyle of community and physical and mental wellbeing.

South and West side residents are also disproportionately affected by pollution and toxins from industrial facilities, due to discriminatory zoning, permitting and land use laws, and lax environmental regulations. <sup>56</sup> Defunding CPD would allow the city to work towards environmental justice, by establishing reparations for past harms and prioritizing clean, sustainable development for working class, communities of color. It would also free up funding for community organizations that

are already actively organizing around sustainable development and environmental justice issues in Chicago.

- » In Little Village, <u>Little Village Environmental</u> <u>Justice Organization</u> organizes around environmental justice issues such as fighting against Exchange 55—a dirty, polluting warehousing facility in Little Village, addressing barriers to water access in Chicagoland Latinx communities, and organizing in the aftermath of the botched Hilco demolition.
- » The <u>Southeast Environmental Task Force</u> works in the Southeast side and south suburbs of Chicago, promoting environmental education, pollution prevention, and sustainable development.

## SECTION 4: TALKING TO YOUR ALDERPERSON

## INTRODUCTION

## WHAT ARE THE GOALS OF THIS SECTION

Section 4 is intended to explain how to engage Alderpersons in defunding CPD. It explains the role of Alderpersons in the shaping the city budget, provides information on past voting records of current Alderpersons, includes talking points for meeting with your Alderperson, and gives instructions for how to set up a meeting with your Alderperson.

## WHO IS THIS FOR?

- » Anyone interested in learning why and how to talk to their Alderperson about defunding CPD.
- » Anyone who wants to learn more about their Alderperson's past voting records and positions.

### WHY TALK TO YOUR ALDERPERSON?

## **How Does Your Alderperson Shape Chicago's Budget?**

Alderpersons are elected officials. As a constituent, you have a direct impact on how your alderperson informs policy. The budget is a moral document; what the city spends this money on shows what they care about. We have a say in this process. Alderpersons can determine how city departments spend their money, write public safety ordinances (like the Civilian Office of Police Accountability [COPA] ordinance),<sup>57</sup> and decide if we build more affordable housing. Alderpersons must approve the Mayor's proposed 2021 budget plan by December 31, 2020. We want to take back the budget, and need the support of our allies in city council to do it.<sup>58</sup>

City council is made of 50 alderpersons, one to represent each ward. There are 19 committees, whose members and chairs are appointed by the Mayor. These appointments are based on an alderperson's specials interests, skills, and relationship to the Mayor (ex: if they supported the Mayor during the election). The Chairperson plays an important role, as they set the agenda for each meeting. Committees like Public Safety (Chris Taliaferro - Ward 29), Finance (Scott Waguespack - Ward 32), and Budget and Operations (Pat Dowell - Ward 3) are instrumental when it comes to defunding the police. In every committee, alderpersons propose Orders, Ordinances, and Resolutions. See the graphic on the right for a visual explanation.

"Legislation is typically introduced at City Council, as an Ordinance (a law, typically amending or adding to the Municipal Code); an Order (addressed to a Department to complete a task); a Resolution (generally more broad, calling upon some type of action or priority). Each Ordinance, Order, or Resolution is referred to a Committee, where an Alderman will work with the Committee Chair and other Aldermen to ensure passage. This is also an opportunity for hearings on legislation, and public comment." <sup>59</sup>

**Bottom Line:** Alderpersons are elected officials that have the power to approve our city's budget. These council members can join and chair committees that play important roles in deciding where funding goes.

## **Making Amendments to the Budget Ordinance**

The budget itself is a 'proposed appropriations' ordinance, which alderpersons have the opportunity to make amendments to. The final vote on the budget is when alderpersons can approve or reject this ordinance.

The mayor needs 26 votes to approve the budget. Last year, 11 alderpersons rejected the budget proposal. These rejections were based on reasons including an inflated police budget, property-tax hike, and exclusionary new minimum wage.<sup>60</sup> Alderpersons who rejected the budget:



If an alderperson sponsored CPAC, Cops out of CPS, or Treatment Not Trauma, this indicates they recognize the harm police cause, and a willingness to consider community-based alternatives to policing.

If an alderperson voted 'No' on the Lincoln Yards Tif, Mayoral Emergency Powers, and the 2020 Budget, this demonstrates a willingness to stand up Mayor Lightfoot's agenda- a pro-police agenda. If they voted 'Yes' on any of these, this indicates their agenda may not align with ours.

## How to Prep for Your Meeting & Important Talking Points

## **Talking to Your Alderperson Based on Their History**

After we've done some homework on our alderperson, let's consider the facts: have they voted yes or no on pro-police measures, such as construction of the Cop Academy? Have they already taken a decisive stance on CPD out of CPS, or defunding the police? Based on these answers, there are different approaches you may want to take when talking to your alderperson.

## BASICALLY, A 'NO'

If our Alderperson has consistently voted yes on pro police measures, criticized protests, demonstrated support of the police, and seconds the Mayor's opinions, it is unlikely they are ready to take a stance to defund the police. Nonetheless, we want to let these alderpersons know that folks who support defunding CPD exist in their wards, and that we're having these conversations within and beyond the area's boundary. Some ideas for this conversation could involve:

- » Tell your alderperson where you stand and why. Consider sharing a personal experience that highlights the need to redirect CPD's nearly \$2 billion funding to mental health services, accessible food and grocery stores, or childcare.
- » Ask them what they would need in order to change their decision. Challenge the assumption that defunding the police simply cannot be done. Record what is keeping an alderperson from joining the movement. Allegiance to the mayor? Public safety concerns? Respond by sharing some facts:
- » CPD has a low clearance rate, meaning few of the crimes reported are actually solved.

- 80-90% of sexual assault cases are not cleared in CPD.<sup>69</sup> In another report, CPD was found 'boosting' their homicide clearance rate by simply closing, with no arrests made, 58%<sup>70</sup> of cases. Do they really keep us safe?
- » Chicago is spending \$82 million<sup>71</sup> a year of taxpayer's money on police misconduct settlements. In just February, city council voted to pay \$11.9 million<sup>72</sup> to cover four of these cases. The family of Heriberto Godinez, who at 24 was killed in police custody, was awarded \$1.2 million. While the family deserves greater justice than this money can serve, why are Chicagoans footing the bill of police brutality?

## 'MAYBE?'

An alderperson who has taken opposing stances or has a conflicting voting record may be swayed to join the campaign. Is your alderperson in the Black or Latino caucus? These caucuses are supposed to address concerns specific to Black and brown folks, such as police brutality. Is your alderperson the chair of a key committee like Public Safety or Finance? They set the agenda in city council, which could give defunding legislation more opportunity for approval.

Here are some talking points to convince your alderperson to join the movement to Defund CPD:

» What are the underfunded areas in your community? Rather than make the conversation heavy on defunding, emphasize how we can redistribute the resources.

## How to Prep for Your Meeting & Important Talking Points

For example, Chicagoans experience food insecurity, exacerbated by a lack of accessible grocery stores. An alderperson has the power to propose an Order to construct a number of new grocery stores in an area within the year. We currently spend \$4 million per day on the CPD—tell your alderperson you'd like to see that money used to build grocery stores.

- » Come with a list of neighbors, businesses, and prominent community members who support defunding CPD. You are not alone: this campaign has nearly 40,000 signatures on our petition to defund CPD by 75%.
- » Is your alderperson the chairperson of a committee? Have they demonstrated a **special interest?** They can bridge those interests with racial equity by prioritizing certain pieces of legislation on the committee agenda. For example, Ordinance 02020-3331 would end the contract between CPD and CPS, removing all police officers from public schools. We know that increased interactions between the police and Black and brown youth directly contributes to the school-to-prison pipeline. By supporting this ordinance, your alderperson has an opportunity to redirect that contract money to funding healthy school meals, tutoring programs, and restorative justice initiatives.

## THEY'RE WITH US

If an alderperson has already stated that they support defunding CPD, it is important that we maintain this stance through collaboration and continued pressure. Thank them for their support and share why defunding CPD is important to you! Ask your Alderperson to commit to an action plan. This could involve:

» Vocalizing support of a direct action. Mayor Lightfoot and her supporters have been persistently critical of protesters while justifying the police's violent responses.<sup>73</sup> We

- need alderpersons in the building to amplify the work done by folks out on the streets.
- » Coalition building with BIPOC-led organizations like Brave Space Alliance, GoodKids MadCity, Chi-Nations Youth Council, Assata's Daughters, and the Black Abolitionist Network. Folks most affected by militarized, over policing are the experts of these experiences. It is important that alderpersons consult them.
- » Proposing an amendment to the budget that defunds CPD and instead funds mental health services, child care, and job programs - things that actually keep us safe. For example, Alderman Rodriguez-Sanchez introduced Treatment Not Trauma, an Order that would create a 24 hour city-wide care and crisis response system.74 Mayor Lightfoot's proposed 2021 budget includes the co-responder model, which dispatches social workers and armed police officers to a scene. Treatment Not Trauma offers a safer alternative, dispatching unarmed mental health professionals who will be sent to a scene of distress to provide deescalation and care. We know that folks experiencing mental illness are 16 times more likely to be killed during interactions with law enforcement.<sup>75</sup> Earlier this year, Chicagoans felt the impact of this statistic when Daniel Prude was killed by police who were called to the scene as he was experiencing a mental health crisis. 76 By supporting this order, your alderperson can reduce the risk of this happening in Chicago.

## How to Prep for Your Meeting & Important Talking Points

## A MARATHON, NOT A RACE

While these conversations are essential to the progress of the campaign, this is only one step to defunding CPD. You only have so much time with an alderperson, so it is strategic to approach with quality over quantity. Reference a few key pieces of

legislation, budget numbers, and facts that you are confident in sharing. While some alders have been dismissive of Chicagoans' demands, we want to try our best to lead with respect and humanity. This level of engagement demonstrates our investment in keeping our communities safe, without the police.

## How to set up a meeting with your alderperson

## **Steps to Talk to Your Alderperson**

Some alderpersons have an "open door" policy when it comes to scheduling meetings. This could mean having a "ward night" where the alderperson is available for phone calls to schedule meetings. Check your alderperson's website to find out. Not all alderpersons have similar policies; keep in mind these meetings will likely be virtual due to the COVID-19 pandemic.

When contacting your ward's office, use whichever method that is most comfortable for you (phone or email). If you don't get a response in 3 days, try the method of communication you did not use on your first attempt.

You may find it easier to go into this meeting with someone else. Feel free to ask someone, like a friend or a neighbor, to attend this meeting with you.

You can find the phone number and email of your alderperson on **chicago.gov**. If their phone and/or email is missing, you may be able to find it on the **Office of the City Clerk website**.

Be sure to make use of the talking points outlined on what to discuss with your alderperson. Additional data on the budget and where we can best use this money instead are found in sections I-III.

## SECTION 5: THE FOP & CONSENT DECREE

## **INTRODUCTION**

## WHAT ARE THE GOALS OF THIS SECTION

Section 5 is intended to debunk the practice of excessive overtime spending justifying the hiring of more polie, explain the barriers that the FOP pose to Defunding CPD, and explain the findings of the DOJ Investigation and the Consent Decree.

## WHO IS THIS FOR?

» Anyone interested in learning about structural obstacles we face on the way to Defunding CPD involving the FOP and the Consent Decree.

### **Costs of Overtime**

## **Costs of Overtime**

The historically high cost of police overtime has been a way for CPD to argue they need to hire more cops as a way to drive down that cost. In 2012, CPD spent \$53 million on overtime, then used that number to justify hiring 400 more cops and increasing police presence in 20 "impact zones."

In 2013, however, CPD spent 96 million on overtime, showing us that their hiring increase just created a larger pool of cops clocking more overtime, with more beat shifts in "impact zones." As of October 6, 2020, Chicago had spent 99.7 million on police overtime.<sup>78</sup> 96 million was what was in the budget for 2020.<sup>79</sup>

## Overtime is used as a justification for the accumulation of resources.<sup>80</sup>

## The Franternal Order of the Police

After the City Council Office of Financial Analysis offered a path to cutting \$55 million from the police department, the City cited contractual obligations as a reason that the City of Chicago wouldn't be able to make those cuts in this budget cycle. The contractual obligations are around tuition reimbursements and uniform allowances, but these things are a part of a labor agreement<sup>81</sup> between the City of Chicago and Lodge 7, the Chicago chapter of the Fraternal Order of Police (FOP or police union).

Lodge 7 represents all sworn police officers below the rank of sergeant. Because they have not been able to come to an agreement, the Chicago FOP and the Mayor have been in negotiations for their next contract since 2017. As the two parties come closer to reaching an impasse, the city still has an opportunity to push for budget restrictions in the next FOP contract. In the meantime, Lodge 7 is still

But there is nothing in the contract that prevents the City from adjusting or reallocating police department funds. The City, as the employer of the Department of Police, has the right to manage its affairs "in each and every respect."

The City also has the power to lay off police officers. Despite the demands from communities that city workers should not be laid off, police officers should be considered fair game since they are not workers in the same way other working class people are. Mayor Lightfoot has pushed back on this option as well, saying that these layoffs would target young officers of color. That is not convincing enough considering police officers of all ages and races uphold a system of violence and oppression

in their role as a police officer.

In the background of these negotiations has been a U.S. Department of Justice investigation into the Chicago Police Department following the murder of Laquan McDonald. The U.S. DOJ investigation led to a federally administered consent decree with just under 100 recommendations and reforms that CPD needed to make. The Chicago FOP has been vocally and visibly against the police department implementing these reforms. Through the examples

## The Department of Justice Investigation & Consent Decree

## The Department of Justice Investigation & Consent Decree

In December of 2015, the Department of Justice launched an investigation into the Chicago Police Department in order to assess CPD policies, training, and accountability after the abhorrent murder of Laquan McDonald. The year-long investigation concluded that the Chicago Police Department "engages in a pattern or practice of unconstitutional use of force" and that it has "deficient accountability systems" that allow for these practices to continue.

The 160-page document highlights numerous examples where the Chicago Police Department has been found to unconstitutionally police Chicago residents. It found that officers continually make decisions that increase the risk of deadly encounters. Even when an officer uses deadly force, inadequate investigation processes, as well as protections from the FOP's collective bargaining agreement, often allow officers to evade accountability.

Our underserved communities with higher crime rates are unjustly and harshly policed, and the police recognize that their behavior will often go unreported. For the victims of unconstitutional force who decide to report officers, justice is infrequently served as the FOP contract requires that the victim complete a sworn affidavit.

According to the DOJ investigation, between 40-60% of all CPD complaints are closed because the victim does not sign a sworn affidavit.

The consent decree went into effect last year in January of 2019 and in its first year, CPD failed to meet 70% of its deadlines.<sup>84</sup> The consent decree has also been brought into question this summer, as the independent monitor of the court order sought to learn about the unconstitutional policing of protestors with unreasonable use of tear gas, batons, and physical force. The consent decree will be in effect until the City and the police department can implement the reforms set in place.

The Consent Decree mandates the Chicago Police Department make changes or improvements in regards to Community Policing, Impartial Policing, Crisis Intervention, Use of Force, and Training for officers, among other things. Just as important as what the changes will be is how much the changes will cost. So far, \$25 million has been allocated toward the reform efforts.<sup>85</sup>

The DOJ Investigation demonstrates that the City should not be allocating nearly 40% of its corporate budget to an organization that has

Due to this report, the federal government has created a court order, a consent decree, to ensure that there are reforms in place in order to ensure the CPD is safely and constitutionally policing the City of Chicago.

**proved it is unable to constitutionally police its residents**, but achieving compliance with this consent decree's reforms will cost even more money.

In a statement this past June, Illinois Attorney General Kwame Raoul made the case (perhaps accidentally) against the reformist reforms embedded in the DOJ's consent decree:

"The obstacle to implementation has never been the consent decree; rather, it has been the Chicago Police Department's failure to prioritize the consent decree by committing sufficient resources to implement the court-ordered reforms. The city and the Chicago Police Department must finally take meaningful steps to implement the consent decree with the sense of urgency this moment in time demands. As tens of thousands of Chicagoans raise their voices to mourn and cry out for change, the city's leadership owes them no less." 86

As Raoul points out, CPD and the city have failed to commit their resources towards implementing court-ordered reforms-- so why should we ever trust them to do so? And even if CPD did meet its deadlines and achieve compliance with this consent decree, its expensive reforms would only serve to expand and entrench a system built to control, harm, and repress people. The consent decree's reforms dangerously legitimize policing as a solution to social, economic and political problems, when in reality, policing perpetuates such problems. In order to address the root causes of the harm that the consent decree seeks to remedy, we must not only fund social services in our most underserved communities, but we must also defund the Chicago Police Department.

- While we cannot know for sure if the school community of Philips Academy High School supports defunding CPD, Phillips Academy has ultimately decided to **REMOVE police** (also known as school resource officers or SROs) from their school site.<sup>7</sup>



# Where can the funding go? Ward Priorities?

The top priorities for Ald. Beale in his ward neighborhoods are the "reduction of violence and public safety, education, and economic development."<sup>23</sup>

To curb violence--particularly gun violence--in his ward. Ald. Beale has advocated for increased police intervention presence, (like programs Cure Violence), random police stops, more community policing, and community investments.24 Beale has made it clear from his previous calls to bring in the National Guard to the south side to "secure a perimeter around the communities" that his vision of public safety is "to police the communities a little bit more."25





WHY: According Austin Weekly News,

Taliaferro believes "efforts to defund the misguided police are and the city should... ensure[] officers are fully equipped while investing in community resources. He went on to say that supporting community needs "can be done without taking [away] resources from our police department."47

In June. he was quoted in the Chicago Tribune, stating

Mitts is one of the main proponents of the \$95 million construction of the Cop Academy, which would be located in West Garfield Park, within the 37th ward. Mitts stated the construction of this training facility will

bring more jobs to the area, is essential to police reform and neighborhood safetv<sup>64</sup>. Her beliefs contradict those of 37th ward residents. who have long protested that this would increase violence police that disproportionately affects Black and brown folks. Additionally, these residents requested that this funding be redirected to community organizations, schools, and social services.65

Alderperson Mitts has advocated for police reforms. In June of 2020. Alderperson Mitts introduced Resolution R2020-451 to city council, is "Call for which Superintendent of Police to report on department progress toward compliance with the... federal consent decree and plans to ensure all police officers engage in constitutional and effective policing." CPD is years behind in fulfilling the consent decree requirements and failed to meet all existing

deadlines<sup>66</sup>. Alderperson Mitts supports CPAC.

October On 21st. 2020. Mitts ioined six other alders (Beale, 9th; Coleman, 16th; Lopez, 15h; Scott, 24th; Ervin, 28th; and Taliaferro, 29th) in a press release that requested the city redirect \$50 million of the CPD budget to violence prevention services. This came in light of the Mayor's insistence that she will not defund the police67.

#### **Ward Priorities**

Economic Sustainability: Mitts wants to increase job availability within the ward through the construction of new businesses and the \$95 million cop academy.

• "The 37th Ward is home to the city's 1st-ever Walmart. I also secured such major retail employers as the Washington Square Mall, CVS Pharmacy, Menards, Coca-Cola and others. I supported the re-opening of the longtime neighborhood business the Buyer's Flea Market after a devastating setback... As chairman of the City Council Licensing and Consumer Protection Committee, I'm proud to have successfully advocated for the expansion of food trucks, pop-up shops. industrial retail thrive zones and other forward-thinking initiatives designed to help support and expand small businesses in my ward and across the city."

Alderperson Mitts sponsored an ordinance that targeted small, Blackowned businesses who made profit off of reselling phones. This is an example of targeting the working class for strategic survival rather than addressing structural problems or big

business tax exemptions on behalf of the wealthy.

- "I was the key sponsor of the Chronic Illegal Activity ordinance, which levied fines, and licensure revocation on neighborhood retail resellers of lost and/or stolen cell phones, which are often used in robberies and other criminal activity.<sup>68</sup>"

Education: Mitts believes education is essential to economic prosperity, but is unclear about plans to pursue this in city council.

"I also know from experience that to fully support sustainable, long-term economic development, you need good, quality schools to generate a well-educated workforce<sup>69</sup>."

Safetv: Alderperson Mitts has resolved to make Austin and West Garfield Park safer by enlisting more police officers. enforcement of firearm laws and criminalization of gang-affiliated young people. We know that increased interactions with police officers leads to increased death and

- "As of this week, 67 new officers are now on the streets, to protect the citizens of Chicago. I will continue my longstanding tradition of working closely with the Chicago Police Department...70"
- "...ensuring enforcement of laws regarding gun and gang violence, and all other unsanctioned, illegal street activities<sup>71</sup>."



Ald. Michele Smith previously served as general counsel for the Engine Group at Navistar International Corporation and before that was a prosecutor for the United States Attorney's Office. Smith was elected in 2011 and currently serves on the following city council committees:

- Budget and Government Operations
- Committee and Rules
- Environmental Protection and Energy
- Ethics and Government Oversight
- Finance
- Health and Human Relations
- License and Consumer Protection
- Public Safety.

Ald. Smith is the Chair of the Committee on Ethics and Government Oversight as well as the Chair on the Joint Committee on Budget and Government Operations; Ethics and Government



Oversight; Public Safety and the Joint Committee on Contracting Oversight and Equity; Ethics and Government Oversight.

# What's her current position on defunding Chicago police?

POSITION: Ald. Michele Smith **OPPOSES** defunding the police.

WHY: Public safety and education are her top concerns.

Ald. Smith advocates for increasing the number of new officers in 18th and 19th district, visibility of officers, and officer patrols.

She is a strong supporter of community policing to decrease youth crime

LINCOLN PARK: Lincoln Park residents are concerned about an increase in violent crime. Residents are calling for an increase in police patrols in response to crimes on CTA and around DePaul campus.

Community members feel they are being under policed and under resourced

Quotes from interviews She's paying lip service with tweets #1 and #3 -- her real opinion is the middle one. Her twitter is filled with posts that are either vaguely or explicitly pro-police.

#### **Ward Priorities?**

According to her ward website, "Alderman Smith views her role as protecting taxpayers from excessive and wasteful spending."<sup>73</sup>

• Also: "She pressured the city to investigate its

absenteeism and overtime problems, which cost the taxpayers unnecessary millions."

- Per her website, she helped to protect a Planned Parenthood clinic -- can identify this and other women-focused resources for her (shelters, physical/ sexual abuse relief/ intervention, etc.)
- She cares about (1) parks and green space--the Lincoln Yards development,
   (2) public safety, (3) public schools. Ald. Smith's approach to issues in the 43rd ward is often MORE police and punishment.<sup>74</sup>
- Although not a stated priority for Ald. Smith, the 43rd ward has LESS THAN 2.5% AFFORDABLE HOUSING.<sup>75</sup>
